




Honorable Judge,





The hearing in the above-captioned case has been rescheduled as follows:

RECORD-HEARING: SEPTEMBER 18, 2008 1:00 PM

For hearings scheduled before the FULL BOARD, parties are required to provide THREE (3) copies of any exhibits intended to be introduced during the hearing. For hearings scheduled before an ADMINISTRATIVE LAW JUDGE, parties are required to provide TWO (2) copies of any exhibits intended to be introduced during the hearing.

The parties are encouraged to exchange documents and witness lists and to discuss all stipulations and possibilities of settlement prior to the start of the hearing.

Requests for continuances are governed under OAC 124-11-03 and must be made in writing at least ten (10) calendar days prior to a scheduled pre-hearing or record hearing date. The granting of such requests is discretionary and must be expressly made.

Subpoenas are governed under OAC 124-11-17 and may be obtained by notifying SPBR. If a party deems it necessary to subpoena more than five (5) witnesses, prior Board approval is required. Witnesses are not required to attend pre-hearings. The Board will not reissue subpoenas when a hearing has been continued unless specifically requested to do so in writing.
